

NAME OF CONTEST: VIRGIN AMERICA NEXT STOP SWEEPSTAKES (the "Promotion"), January 2012.

SPONSOR: Virgin America Inc.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY REQUIREMENTS: The Promotion is open only to individuals who 1) are legal residents of the United States 2) are eighteen (18) years of age or older at the time of entry; 3) have access to the Internet and have not purchased Internet service in order to participate in this Promotion; and 4) are not employees, officers, directors, immediate family members (spouse, parent, child, sibling or their respective spouses, regardless of where they reside, or member of the same household, whether or not related) of Virgin America Inc., or each of their respective parent(s), affiliated companies, subsidiaries, licensees, advertising and promotion agencies (collectively, the "Sponsor"), and any and all other companies associated with the Promotion. Individuals who meet the above requirements are referred to as "Eligible Entrants." The Promotion is subject to all applicable federal, state and local laws, rules and regulations. HOW TO ENTER: The Promotion begins at 09:00am PST, January 17, 2012 and ends at 11:59pm PST, January 31, 2012 ("Entry Period").

During the Promotion Period, visit <http://vgn.am/nextstop> and follow the links and instructions to complete and submit the registration form including a valid email address and phone number. You automatically will receive one (1) entry into the Sweepstakes.

Limit one (1) entry per email account. The Sponsor is not responsible for entries that, for any reason, are not received for any reason, or for entries that are received, but are not decipherable for any reason.

WINNER DETERMINATION: The winners of the Promotion will be randomly selected from among all eligible entries received during the Entry Period. One winner will be selected and can invite a guest. The decisions of the Sponsor are final and binding on all matters relating to this Promotion. Odds of winning depend on the total number of eligible entries received.

A potential winner will be required to sign an Affidavit of Eligibility, a Liability/Publicity Release and a W-9 tax form or a W-8 BEN tax form within ten (10) days of notification.
